THE INTERNATIONAL YEAR OF CAVES AND KARST: BECOME A PART OF SPELEOLOGICAL HISTORY

ear speleologists and cavers around the world. We are pleased to bring you another issue of the UIS Bulletin, which pages, as usual, bring important, historic, and good news about the activities of the UIS itself and global speleology.

As everybody knows, 2021 was yet a hard year due to the unexpected extent of the coronavirus pandemic. Thus, virtual activities continued dominating the speleological scenario worldwide. Even so, the overall balance of this year is highly positive, especially in the context of events held in support of the International Year of Caves and Karst (IYCK).

Since its launch in January, we could see a significant increase in participation in this UIS project. It's up to us, therefore, to continue our work of encouragement so that this engagement continues to rise until the end of 2022, when the UIS will gather in a single document all the activities carried out on behalf of the IYCK throughout the planet.

One of the highlights of this list will undoubtedly be the commemorative event at UNESCO Headquarters in Paris, which was a historic moment not only for the UIS itself but for the entire world's speleology. As commented by the UIS President George Veni in his column on the next page, it "marks not only a great achievement for speleology, but a new beginning." The entire saga covered by the UIS until reaching the UNESCO Headquarters begins on page 12 and includes the details of the ceremony itself and future perspectives. Remembering that the event at UNESCO was number 300 on behalf of the IYCK and that we will still had 3 months left in 2021 and the whole year of 2022, many good results are expected to come.

In the field of protection of cave fauna, for the second year in a row, the biospeleological community of the countries participating in the project "Cave Animal of the Year" has elected a single animal as the representative. Whereas in 2021 the honor fell to the beetles, the article on *page 25* shows that for 2022 bats were selected. The purpose of the choice is to raise global awareness of their importance for the ecosystem in which they inhabit—caves mostly—and their need for protection.

On *page 26* the UIS Commission on Glacier, Firn, and Ice Caves present the "Palaeolus Scientific Project,"

with a link for the interesting movie produced during a caving expedition in the White Mountains of Crete, Greece.

Regarding the UIS congresses, it is time to plan our trip to France. Not by chance the 18th International Congress of Speleology (ICS) receives special attention on this issue. After having been forced to postpone the event due to the pandemic, the French people are excited to welcome the international speleological community in Le Bourget Du Lac from 24-31 July 2022.

Besides being the major event of the IYCK, a lot of attractions are waiting for you at the International Congress, such as the scientific conference, videos, bookshops, stands from vendors and caving organizations, equipped caves, and beaches of the Lake Bourget too. So, don't miss it! The new poster and the 3th Circular are on *pages 5 to 11*. For more information, visit https://uis2021.speleos.fr/.

When you have your bags ready and your schedule defined for the 18th ICS, you are invited to start thinking about the next one, in 2025, when the UIS Congress will land again in the southern hemisphere, for the second time in Brazil. In the previous issue of this Bulletin we talked about the selection of Brazil by the UIS Delegates and provided some information about Belo Horizonte—the host city—as well as some options for the excursions.

This time, on *page 27*, you will learn of the main advances of the congress' organization over these past six months, including the description of the venue.

Many other speleological events and activities are scheduled for 2022, and further—see the Calendar on *page 45*. All of them represent special occasions to promote the IYCK, and grow cave and karst conservation awareness beyond the speleological audience.

You can participate or create your own event or activity for the IYCK. The important thing is to make your contribution, to help each event to become a historic moment for speleology. The UIS is ready to publish your results. The UIS Bulletin, of course, is among the several UIS media and will be proud to have your event on its pages.





The President's Column

A NEW BEGINNING FOR SPELEOLOGY AND THE SECOND YEAR OF THE INTERNATIONAL YEAR

peleology has enjoyed many excellent and important events around the world. Certainly, the International Congresses of Speleology are among the most important for research, and for international fellowship to spur new exploration and projects. But on 13 September 2021, the most important event occurred in Paris, France, at the headquarters of UNESCO—the United Nations Educational, Scientific, and Cultural Organization.

The UIS was invited by the UNESCO Director-General to celebrate the International Year of Caves

and Karst at UNESCO Headquarters. Until then, speleology has never had a chance to meet directly with a globally international governmental organization, to teach its leaders face-to-face about the importance of caves and karst. For decades, cavers struggled to get their local, regional, and national leaders to protect caves and karst. For decades, cave scientists struggled for respect in the scientific community. The worst of those times are now behind us. Together, we have made great progress, which led us to UNESCO. The celebration there marks not only a great achievement for speleology, but a new beginning.

Further in this issue you will read about the celebration and its presentations, and meetings. We should be proud of that incredible event and use it to inspire our work, especially for the International Year. More importantly, we must see this celebration as an opportunity to advance speleology in

ways not possible until now. The UIS is continuing to meet with UNESCO staff and representatives to build on the celebration and the goals of the International Year. Like with the International Year, the UIS Bureau cannot succeed alone. We need everyone to participate.

By supporting each other, we can continue doing great things. More importantly, we need to aspire and reach for greater things. Cave and karst science is now respected globally. We must use that respect, and the credibility that UNESCO gave us through their invitation, to seek meetings at higher government levels for better protection and management. We can use that respect and credibility to request more funding for research and exploration of caves. By showing this international respect to the news media, we can get more publicity and use them to help us teach the public about the value of caves and karst.

As we start the second year of the International Year of Caves and Karst, I call on every speleologist

to double their efforts in reaching and teaching the world about these fabulous places we hold dear because we understand how truly special they are. I ask all of you to plan more events and activities and reach out to bigger audiences and higher people in your societies and governments. Proudly tell them that UNESCO invited us to celebrate caves and karst with them because caves and karst are important, sensitive to damage, and need protection. Make it clear that you are not alone and that the international community supports the theme of the International Year: Explore, Understand, Protect.

I am not promising that you will see instant results and support. I am promising that if we continue working together, around the world, that the increase in knowledge and appreciation for caves and karst will grow until we see clear and positive results everywhere. Remember that


a rising tide lifts all boats. In some places, such success may only come after many years, but it will come and be made easier as the truth of our work surrounds and lifts all nations.



The road to the UIS INTERNATIONAL YEAR OF CAVES AND KARST 2021 and UNESCO event

e just finished 2021, which was declared the International Year of Caves and Karst (IYCK) by the UIS, and which was extended through 2022 because of the Covid 19 pandemic. There are hundreds of cave and karst events being organized by various IYCK partners around the world, and many of these events have been completed or are scheduled to be held in the near future. All of us, cavers, karst scientists and managers of karst and caves, can be proud of the response to the IYCK.

The UIS, at the level of the UIS Bureau and the IYCK 2021 Organizing Committee (George Veni, Fadi Nader, Zdeněk Motyčka, Nadja Zupan Hajna, Bärbel Vogel and Gyula Hegedűs) has not only organized the whole International Year, but we also organized the virtual opening of the IYCK 2021 in January 2021, and the event at the United Nations Educational, Scientific, and Cultural Organization (UNESCO) Headquarters in Paris, France, in September. We also prepared the text for the IYCK website, leaflets, and posters. The entire UIS IYCK 2021 and events follow the program framework:

- I Opening of the IYCK;
- II Sharing Cave and Karst Knowledge Exchange: International Scientific Conferences and Public Exhibitions;
- III Promoting the Value of Caves and Karst World Heritage;
- IV Sharing Cave and Karst Knowledge: Show Caves Karst Tourism; and
- V Closing Ceremony of the IYCK.

We can say that the event celebrating the UIS International Year of Caves and Karst 2021 at UNESCO in Paris entitled *UIS IYCK 2021: UNESCO Protected Areas and UN Agenda 2030* has been successfully completed.

The event was organized under the patronage of the UNESCO Director General by the UIS in partnership with the Permanent Delegation of the Republic of Slovenia to UNESCO. About 190 invited participants were present at the UNESCO Headquarters in Paris or followed the event live via Zoom and YouTube. Over a thousand watched the recording of the event shortly after. The event was a great honor and a unique opportunity for the entire speleological community to present the beauties and issues related to caves and karst at a high political level. It was truly unique for UIS to be a part of UNESCO and we hope that caves, karst resources, cavers, and researchers will benefit from this celebration, and also from all the activities of IYCK 2021.

Here I provide an overview of the main steps and obstacles we encountered in organizing IYCK 2021 and the UNESCO event in Paris. This does not take into account the countless meetings, arrangements and preparations of the UIS Bureau (members of 2013-2017 and 2017-2021) and the IYCK 2021 Organizing Committee.

IMPORTANT STEPS IN ORGANIZING THE IYCK 2021 AND UNESCO EVENT

- **2015, June:** at the UIS 50th Anniversary Celebration in Postojna, Slovenia, on the initiative of Kyung Sik Woo (*Rep. Korea, UIS President 2013-2017*) we released the Declaration of the UIS to organize a UNESCO International Year of Caves and Karst in 2021.
- 2016, April: Kyung Sik Woo and Fadi Nader send a letter to all national commissions for UNESCO with the proposal to consider taking an active role in proclaiming 2021 as the International Year of Caves and Karst to UNESCO.



- **2016, June:** Nadja Zupan Hajna receives instructions on the process to reach UN for 2021 as International Year after a meeting with the Director of the UNESCO Office in Slovenia, M. Hafner.
- **2016, June-October:** UIS receives letters of support for UNESCO IYCK 2021 from the National Commission for UNESCO: Slovenia (mediation Nadja Zupan Hajna), Croatia (mediation Mladen Garašić), Belgium (mediation Jean-Pierre Bartholeyns), and Hungary (mediation Gyula Heged ÜS).
- 2016, November: Nadja Zupan Hajna receives instructions on the procedures for proclaiming IYCK as a UN/UNESCO year after meeting with the Director of the UNESCO Office in Slovenia, M. Hafner, and prepares a first proposal for the IYCK 2021 program.
- **2016, November:** Kyung Sik Woo receives various instructions on procedures from the South Korean UNESCO Delegation.
- 2016, December: Nadja Zupan Hajna meets with the President of the Slovenian National Commission for UNESCO, Ms. Pejovnik, and Director of the UNESCO office, M. Hafner; she discusses the procedures, program and applies for UIS approval of Slovenia to start the procedures.
- 2017, January: Nadja Zupan Hajna is informed by the Director of the UNESCO office, M. Hafner, that they do not understand what the UIS actually wants, and after the UIS did not clarify that Slovenia is leading the project, the Commission stopped working on the proclamation—the UIS missed their deadine.

- They will continue to support any UIS motion on the IYCK or Caves and Karst Day if it comes to that, but will not take the lead.
- **2017**, **January:** Nadja Zupan Hajna with approval of the UIS Bureau has prepared a plan for IYCK 2021 activities with a projected budget. UIS is also looking for a new country to propose the IYCK at UNESCO.
- 2017, January: Fadi Nader meets with the Lebanese Ambassador at UNESCO, who supported the IYCK and suggested Slovenia to cooperate with Lebanon on the proposal to UNESCO. Fadi also works with French cavers to get France to join the proposal.
- 2017, February: Fadi Nader, Nadja Zupan Hajna, and the French Federation of Speleology-FFS (Gael Kaneko and Vincent Biot) meet at the *Maison de l'UNES-CO* in Paris with the ambassadors of France, Lebanon and Slovenia. The ambassadors inform them that it is very late to pursue the 2021 UNESCO proposal, but that they will support it if it comes to pass. They also give the idea of a week or day-long celebration of caves and karst at UNESCO Headquarters in Paris to reach out to the public.
- 2017, February: Kyung Sik Woo contacts Patrick McKeever, UNESCO Earth Science Programs and UNESCO's Man and Biosphere Programme (MAB) and asks to make a proposal for the UN 2021 International Year of Caves and Karst. Kyung Sik also sends a letter to Yuan Dioxian regarding China's participation in the IYCK proposal at UNESCO and makes contact with the South Korean Commission at UNESCO. There are no positive responses.



19 June 2015: During the 50th Anniversary of the International Union of Speleology at Postojna Cave in Slovenia, UIS President Kyung Sik Woo reads the Declaration: UIS Proposes to Organize a UNESCO International Year of Caves and Karst, supported by UIS Bureau members and past presidents.



- **2017, June:** Gyula Hegedűs receives a letter from the Hungarian National Commission for UNESCO, that Hungary is willing to support our proposal if there is a country that makes the proposal.
- **2017, July:** the UIS office is mandated by the UIS Assembly and delegates for the new UIS Bureau to achieve IYCK 2021.
- **2017, September:** negotiations with China to support IYCK; they propose to lead it instead of UIS, which UIS doesn't support (the IYCK is a UIS idea).
- 2017, October: Fadi Nader and Gael Kaneko (FFS) meet with French Ambassador in Paris at UNES-CO. Mr. Stefanini informs them that he will not forward the proposal to the Council of UNESCO at this stage, as the idea of International Year is currently not promoted much by UNESCO and the UN. He proposes to UIS (& all member countries) and partner organizations to organize a UIS-led IYCK for 2021.
- **2017, December 2021:** George Veni, Kyung Sik Woo and Fadi Nader send a request for support for IYCK to international, regional, national, local and professional organizations, institutions and societies.
 - 2018, March: UIS gets final answer that the


French government will not make a proposal for an International Year of Caves and Karst at this stage.

- **2018, August:** IYCK 2021 Organizing Committee (working group out of UIS Bureau members) is established.
- 2019, January: Nadja Zupan Hajna meets regarding UIS IYCK 2021 with the Slovenian UNESCO Commission and representatives of the Slovenian Ministry of Foreign Affairs, the Ministry of Environment and Spatial Planning and the Ministry of Economic Development and Technology-Tourism to discuss the participation and level of cooperation of the Republic of Slovenia in the UIS initiative(s).

They propose to ask the UNESCO General Assembly for patronage for an event at UNESCO Headquarters in Paris. They also support the idea of proposing an International Caves and Karst Day!

- 2019, February: Alexander Klimchouk informs that the National Commission of Ukraine for UNESCO has agreed that Ukraine officially submits the IYCK proposal to UNESCO-UN as UN IYCK 2025.
- **2019, February:** UIS Bureau votes YES to hold an event for IYCK 2021 at UNESCO Headquarters in Paris.

- 2019, March: Nadja Zupan Hajna meets with the Director of the UNESCO Office, M. Hafner, regarding the procedure for obtaining the patronage of the UNESCO Director General over the UNESCO event. The procedure has to go through the Slovenian Delegation as the UIS is registered in Slovenia.
- 2019, March: Fadi Nader and Nadja Zupan Hajna meet with the Slovenian, Lebanese and French Ambassadors to UNESCO at UNESCO in Paris. The Ambassadors state emphatically that we need to focus on UIS IYCK 2021. The reason was that the International Years and Days are still not popular with many in UNESCO and the UN. However, if we run a successful UIS IYCK in 2021, including our opening ceremony at UNESCO, we can educate delegates about the importance of caves and karst, and then we would have a good chance of getting the UNESCO year and/or day approved for 2025 as well.
- **2019, March:** The UIS IYCK Committee looks for letters of support from the UNESCO national commissions for a UNESCO IYCK event in Paris; UIS receives the support of Lebanon (*mediation Fadi Nader*).
- 2019, May: Nadja Zupan Hajna receives confirmation from the Permanent Delegation of Slovenia UNESCO that they will cooperate at the organization of the UNESCO Paris IYCK 2021 event.
- 2019, May: Nadja Zupan Hajna meets with the Director of the UNESCO Office, M. Hafner, regarding the preparation of the UNESCO General Assembly patronage application, its submission and the program of the event at UNESCO Headquarters. This is followed by preparations for UIS IYCK 2021 and the UNESCO event.

- **2019, November:** On the advice of the Slovenian National Commission UNESCO, Nadja prepares a proposal for the program of the opening ceremony in Paris.
- 2020, January: Fadi Nader and Nadja Zupan Hajna meet with the Lebanese Ambassador to UNESCO at UNESCO, with the Slovenian Ambassador at the Embassy of the Republic of Slovenia, and with representatives of the French National Commission for UNESCO in Paris.
- **2020, March:** UIS receives Serbia's support (*mediation Jelena Čalić*) for UNESCO Paris IYCK 2021 event.
- **2020, April:** Slovenian National Commission for UNESCO submits application for patronage.
- **2020, August:** Slovenian National Commission for UNESCO receives a letter from the UNESCO General Assembly granting the IYCK 2021 event in Paris.
- 2020, June 2021, September: Nadja Zupan works on the procedures and agreements (see page 18) between the UIS and the Slovenian Ministry of Foreign Affairs for covering the costs of the UNES-CO IYCK 2021 event. If the event is co-organized with the Permanent Delegation of Slovenia to UNESCO in Paris, all costs will be much lower (internal prices).
- 2020, June 2021, September: Nadja Zupan works on the program and technical organization of the IYCK 2021 UNESCO event with the Permanent Delegation of Slovenia at UNESCO in Paris.
- 2021, May September: Nadja Zupan works on the invitations for the Permanent Delegations of the UNESCO countries with karst and caves and on the technical organization of the UNESCO IYCK 2021 event with the Permanent Delegation of

Slovenia at UNESCO in Paris.

• 2021, September 13: preparation and implementation of the event at UNESCO House, 7 Place de Fontenoy in Paris, elimination of technical deficiencies, establishment of a streaming on the YouTube UIS channel, presentations, posters, UIS Bureau lunch with UNESCO delegations and officials.

The challenges we have faced in relation to the International Year of Caves and Karst 2021 as UNESCO International Year are perhaps best illustrated by the following example. It clearly shows the implications for the UIS Bureau if we have wanted to make the UNESCO Year of Caves and Karst 2021 a reality.

Letter to the UIS Bureau regarding UNESCO IYCK 2021 by Nadja Zupan Hajna, 30 November 2016

Dear all,

In this mail I include also past presidents, Paul Williams as IUCN and Gyula Hegedűs as we have support from Hungary.

I have got a call from Slovenian UNESCO General secretary (Director of UNESCO office) Mrs. Marjutka Hafner. She invited me on the meeting with her and Slovenia UNESCO President Prof. Dr. Pejovnik what to do regarding Intl. Year of Caves and Karst, if UIS wants that Slovenia (or other country) starts the procedure. The meeting will be on December 11 or 12; for that meeting I have to have UIS statements!

STATE OF THE ART:

- a. Written support from: Slovenia, Croatia, Belgium, Hungary; mutual promises: France, China, Lebanon.
- b. Nothing was done regarding IYCK 2021 at the Paris meeting of UNESCO Executive Committee, October 2016, because there was some incomprehension between the information we gave M. Hafner regarding Belgium and what Belgium offered regarding organization of procedure. J.P. Bartholeyns wanted that I gave M. Hafner contacts that Belgium delegation will come in contact with Slovene and start the work, but they didn't. M. Hafner was waiting before and at the meeting that somebody will come to talk with here or will start the procedure; but too late she has realized that Belgium is not Executive Committee member.

Mrs. Hafner during phone call stated what I have to know before meeting (below). After they can arrange also meeting in Paris with Fadi and Slovene UNESCO permanent delegation and of other countries which we invite.

THERE ARE CRUCIAL QUESTIONS:

- 1. which country will lead the work (and at least 1 more involved);
- **2.** who of UIS Bureau will lead and really work on the organization (perhaps to establish working group), reality: it will be nonpaid hard work with not paid travel costs (not forget we are volunteers!)
- **3.** what we have prepared to offer to UNESCO/member countries implementing this project in the widest context (caves, the karst, groundwater, nature protection, tourism etc.)? Kyung Sik, will you prepare the frame before my meeting, perhaps with Paul Williams help, or I have to do it? Voting on this questions for Bureau members?

PROCEDURE (LETTER OF MRS HAFNER IS TRANSLATED FROM SLOVENIAN LANGUAGE) WHERE I EMPHASIZE IMPORTANT PARTS:

1. UN proclaims the IY, UNESCO may only proclaim international days (proclaimed by the UNESCO General Committee). With the aim of raising global awareness, countries may decide to adopt a decision in their materials that the UNESCO GC take a decision for the final proclamation to be made by the UN General Assembly. However, the UNESCO GC has no authority to proclaim international years, which lies within the jurisdiction

of the UN General Assembly (which on the other hand may also proclaim international days, such as, for instance, the world bee day, for which we are preparing). A year/day at the UN General Assembly requires the involvement of the entire diplomatic network at the UN in New York and around the world.

- 2. The decision to submit a proposal for the proclamation of an international year, where for instance Slovenia would be the lead country, signifies a huge project on which the country must embark on a governmental level. By way of example we can cite the proposal for proclamation of a bee day at the UN General Assembly, where the activities of the capital ministry and other stakeholders were very intensive, while the proclamation of a year would require even more activity. (Before deliberating over the initiative at the UN General Assembly, Slovenia had to obtain the support of the FAO? the organization at the UN specialized in issues of food security and sustainable development of agriculture, similar to UNESCO).
- **3.** In our case the initiative would be launched by the International Union of Speleology (UIS), which, however, requires a member country of the international organization in order to launch and manage the procedure (support, media awareness, seeking funds). For this reason, the Government/other departments would need to take a position; in Slovenia for instance: Ministry of Foreign Affairs, Ministry of the Environment and Spatial Planning, perhaps the Ministry of Agriculture, Forestry and Food and Ministry of Economic Development and Technology. In the preliminary phase at least one country that is a member of the Executive Board would need to be involved. Slovenia is at the moment.
- **4.** On a possible agreement to the proposal and assuming that the proposal would succeed, a clear picture would need to be formulated as soon as possible regarding what, if anything, Slovenia might expect from implementing this project in the widest context (caves, the karst, groundwater, nature protection, tourism etc.).
- **5.** As for a timeframe, we would highlight the following, for the moment this information is available:
- A proposal would need to be submitted for deliberation at the 2017st spring session of EXB (i.e. by April 2017, possibly also at the autumn 202nd session), with a resolution that the decision is to be adopted by the UNESCO GC in November 2017. This is a little problematic because at the 201st session we already have the addressed material on freely accessible educational resources, where Slovenia is the lead country.
- Decision of the UNESCO GC of November 2017 to support activities for adoption at the UN General Assembly in 2018-2019,
- Decision of UN General Assembly 2018-2019 (as already set out).
- Example: procedure for 2015 International Year of Light and Light-based Technologies, website: http://www.light2015.org/Home.html

It was impossible to get the signed approval from the UIS Bureau in time for Slovenia to initiate the procedure as the lead country due to different instructions on the procedures from Korea, other interests and slow reactions from the UIS. For this reason, the Slovenian National Commission for UNESCO resigned from further actions in early 2017, with a promise to support any UIS action regarding IYCK 2021.

UIS was looking for a new country to start the process on the UNESCO level (e.g. Republic of Korea, United Kingdom, People's Republic of China, France), but was unsuccessful until Alexander Klimchouk received confirmation from the National Commission of Ukraine for UNESCO in 2019 that it had agreed that Ukraine officially submitting the IYCK proposal to UNESCO-UN as UN IYCK 2025.

After the UIS received plans for a karst/cave event at UNESCO Headquarters in 2021, and the UIS wanted to hold IYCK-2021 at its own level as a preparatory campaign for a IYCK-2025, communication with Ukraine ended. It was too much work for the Organizing Committee of IYCK 2021 to follow all the preparations with IYCK 2021 and the procedures requested at UNESCO.

Keeping the procedure with Ukraine would mean that the proposal for IYCK-2025 would have to be included in the agenda of GC-41 in 2021 and pass the Executive Committee in 2020 (spring or fall), which was not realized. Since the UIS was not able to communicate instructions to Ukraine after 2019, the Ukrainian National Commission for UNESCO was very disappointed.

In reality, during our meetings with Ambassadors (2017, 2019, 2020) as UIS representatives, I and Fadi also realized that we are amateurs at such a high international political level and we (UIS) cannot easily

lobby at the UNESCO level (first in the Executive Committee UNESCO member countries to put proposal to their meeting agenda for discussion, and after vote for it at the UNESCO General Congress), not even to mention lobbying at UN level. And to remind ourselves: we are unpaid volunteers!

The UNESCO Headquarters event in Paris also encountered many obstacles. First, we had to prepare an application for the patronage of the UNESCO Director General for the Opening Ceremony of the IYCK 2021 in Paris, and then submit it to UNESCO through Slovenia, where the UIS is registered, with the support of other countries (we received the support of Lebanon, Hungary and Serbia). When we received the positive answer about the UNESCO General Assembly's patronage, we chose January 26, 2021 as the date for the Opening Ceremony. But already in the summer of 2020 it was clear that due to the Covid 19 pandemic it would not be possible to have the event live in Paris. So we decided to broadcast it via the UIS YouTube channel.

The Opening Ceremony of the IYCK 2021 started with welcomes from the UIS Bureau members, a talk about caves, karst, their values and challenges, news about the first International Cave Animal of the Year, information about the International Year and an IYCK video at the end. In April 2021 we started looking for a suitable date for the IYCK celebration in Paris. As June was still not possible, we decided to hold it in September.

The UIS International Year of Caves and Karst 2021 celebration at UNESCO in Paris on 13 September between 9:30 a.m. and 1:30 p.m. was attended by over 50 participants, with 136 connected via Zoom (averaging 60-70 at any single time) and around 70 via the YouTube channel during the event, with over 1,200 views to date. Four years of work on this task is now complete.

All meetings with embassies, national UNESCO commissions, Zoom meetings of the organizing committee, countless emails between the Permanent Delegation of Slovenia on UNESCO, UNESCO technical officials were coordinated with me. The extremely important event for the promotion of caves and karst was prepared in detail by the UIS Organizing Committee of IYCK 2021 with the support of the UIS Bureau, and the help of the Permanent Delegation of Slovenia to UNESCO.

I must apologize to all participants in the audience who attended by Zoom and the UIS YouTube channel for some technical shortcomings. Perhaps we are spoiled by the excellent organization of scientific conferences and meetings on caves and karst? The technical realization was not in the hands of UIS or the Slovenian Delegation. We organized everything in advance, prepared the IYCK video, the program, the texts, the presentations, the books and the delivery of the posters, held a technical meeting with UNESCO three weeks in advance, but some things did not go smoothly. The technical staff was not prepared fully, and the computers and Internet connection were working poorly.

For example, YouTube streaming was not connected until the last few minutes—thanks to Anja Hajna who made the connection. I also played presentations and videos before the start and they worked. But when the ceremony started it was a disappointment: lights, mouse/spacebar on the presentation computer, reaction time and resolution of the presentations were slow due to the computer and the Zoom connection.

Because of all these, I was so tired that I could barely present my PowerPoint. In hindsight, I was very disappointed because even though I prepared for a long time, I did not have the energy to give a good presentation.

But as I said, it was great to give a presentation about caves, karst and their threats on UNESCO. And in the end most of the audience, the ambassadors and delegates of the permanent delegations present at UNESCO were very satisfied and congratulated UIS for the well prepared and organized event.

My thanks go to everyone who were involved in the organization of the UNESCO IYCK 2021 Paris event, to all participants who supported us on the internet and especially to the Permanent Delegation of Slovenia to UNESCO, which was our co-organizer.

Not to be forgotten are also the financial contributions (donations to the UIS account, costs of layout and printing of leaflets, posters and book) and the volunteer hours for the organization and publications of IYCK 2021 by members of the UIS Bureau and the ZRC SAZU Karst Research Institute.

The UIS would like to thank Jasmina Rijavec for setting up the IYCK 2021 website and taking care of the publication of the events and reports, all the UIS social media managers: for UIS Facebook Jasmina Rijavec and Anja Hajna, for the UIS YouTube channel Anja Hajna, and for UIS Instagram and Twitter Ayumi Okouchi for publishing the IYCK 2021 materials, and all the photographers who donated their photos for the IYCK publicity.

I must emphasize that I have spent many hours preparing the IYCK (when I could be doing other things, including caving), but I am glad to be doing it, especially if people become more aware of the importance of karst and caves to their lives. UIS INTERNATIONAL YEAR OF CAVES AND KARST 2021

The most important event in history for Speleology

Special ceremony at UNESCO Headquarters in Paris

n the morning of September 13th, the International Union of Speleology (UIS), represented by twelve members of its current and past bureaus, experienced a highly significant moment in the history of speleology. Accompanied by governmental ambassadors and national delegates, as well as several karst scientists, the group was welcomed to the United Nations Educational, Scientific, and Cultural Organization's (UNESCO) Headquarters in Paris for a ceremony celebrating the International Year of Caves and Karst (IYCK).

This celebration was scheduled for January 2021 as the official launch of the IYCK, but due to the Coronavirus pandemic the opening of the International Year

was conducted virtually without the presence of UNESCO. Since January, activities related to IYCK have multiplied around the planet and the UIS has stayed in continuous close contact with UNESCO so that, after four years of negotiations and adjustments, the long-awaited face-to-face ceremony could finally be held.

During this long period, this extremely important event for the promotion of caves and karst was prepared in detail by the UIS IYCK Organizing Committee, with the support of the UIS Bureau and co-organization of the Permanent Delegation of Slovenia of UNESCO, without which the event would not have been possible. Numerous were the meetings with embassies, national

commissions and UNESCO technicians, hundreds of emails and many Zoom meetings to discuss details, invite authorities, arrange a lunch and a buffet for the coffee break, elaborate posters and promotional materials.

The six posters prepared by the UIS hall providing information about the:

- IYCK itself.
- worldwide extent and fragility of the karst areas,
- risks of karst degradation,
- the delicate fauna in caves,
- · cave and karst education, and
- sustainable management

All were illustrated perfectly and explained with succinct and understandable text for an audience not directly involved with the speleological world. They were arranged strategically to get the attention of the participants upon their arrival. In the same space, IYCK brochures and copies of the book *Karst, Caves and People*—produced exclusively for IYCK—were made available to all present so that later, they could relax at home and reinforce their understanding of the dynamics of these landscapes and the importance of protecting them. Completing the assembly, a morning buffet contributed to welcoming those who arrived for the ceremony.

THE UIS-UNESCO RELATIONSHIP

Before discussing the IYCK celebration further, it is important to take a brief journey back in time to record the history of UIS and UNESCO's relationship.

UIS began formally approaching UNESCO in the early 1970s. On June 5, 1975, UIS had its request for

recognition confirmed and was admitted as an international non-governmental organization (NGO) in Category C, that is, with the right only to exchange information with UNESCO. Recognition as Category B (Advisory Organization) took place on August 23, 1983, after the then UIS President Adolfo Eraso Romero's efforts.

UIS participation in UNESCO ended after the major reorganization of the UNESCO structure in 1997 (i.e. changed system of affiliation of NGOs). At that time, UIS did not meet the requirements of UNESCO for an "affiliated" organization, as UIS had no stable address, was not officially registered in any country and had no possibility to have a permanent secretariat—registered at UNESCO—in Paris with employees. Most importantly, UIS never participated in the annual November General Assemblies (time consuming, about 3-6 weeks, and costly).

Time passed, and UIS continued to seek important recognitions to elevate its status as a worldwide organization. As a result, in 2010, UIS was accepted as an Affiliate member of the International Council of Scientific Unions (ICSU), an organization dedicated to international cooperation for the advancement of science. In 2017, as a result of the merger with the International Social Science Council (ISSC), it became the International Science Council (ISC, https://council.science/pt/), the only international non-governmental organization that brings together the natural and social sciences and also the largest global scientific organization of its kind.

UNESCO itself, however, has never left the UIS radar. In 2015, during the UIS 50th Anniversary celebration where the goal of organizing the International Year of Caves and Karst in 2021 was declared, the focus

was to fit it into the scope of UNESCO, which would bring much more visibility. As time went on, talks with UNESCO ambassadors and delegates revealed that UNESCO now rarely recognizes International Years as official UNESCO events. But seeing the formal support of delegations from various countries and more than a hundred international organizations, the UNESCO Director-General gave the patronage for the UIS to celebrate the IYCK at the UNESCO Headquarter in Paris (see pages 12-19 for the detailed report on the planning for the IYCK and the celebration).

HISTORIC CEREMONY

The IYCK ceremony itself began with a big screen showing virtual participants from around the world. In all, 136 people connected via Zoom and about 70 via the UIS's YouTube channel (which has since been watched more than 1,200 times). Remembering that at 9:30 a.m. in France was 11:30 p.m. to 5:30 a.m. in the Americas, and other inconvenient times elsewhere, we are grateful to those who could attend and show their support.

In Room XI of the iconic UNESCO Headquarters, located in the heart of Paris, 1.5 km from the famous Eiffel Tower, around 50 people settled into the seats.

Many more people would have been present if not for the limitations imposed by UNESCO due to the pandemic.

Starting the celebration, moderator Prof. Dr. Alik Ismail-Zadeh (Azerbaijan, Secretary General of the International Council of Science), made a brief presentation on the IYCK and its goals, followed by the IYCK video, available at the link https://www.youtube.com/watch?v=sw1YOSNXSvs&t=34s (currently seen more than 10,600 times!).

After the video, welcome addresses were given by:

- Mr. Ernesto Ottone Ramirez (Chile, UNESCO Assistant Director-General for Culture on behalf of Mrs. Audrey Azoulay, UNESCO Director-General);
- H. E. Mrs. Meta Ipavic (Slovenia, Ambassador of Republic of Slovenia in France, and Permanent Delegate of Slovenia to UNESCO);
- Dr. George Veni (USA, UIS President, Executive Director, National Cave and Karst Research Institute-NCKRI), and
- **Prof. Dr. Alik Ismail-Zadeh** (Azerbaijan, Secretary of the ISC Governing Board).

In his speech, Dr. Veni highlighted three wishes of the UIS with the event:

1- Encourage UNESCO to develop inventories of all caves, karstic features, and their contents in UNESCO protected areas.

- 2- Suggest that UNESCO evaluate protected areas for the adequacy of cave and karst protection and expand protection if necessary.
- 3- Invite UNESCO to join the UIS in the development of actions aimed at an international ban on the trade in products from caves (speleothems, animals, sediments, rocks, etc.).

Then came the keynote presentation:

• "A World of Karst, Caves and People," by Prof. Dr. Nadja Zupan Hajna (Slovenia, UIS Treasurer, ZRC SAZU Karst Research Institute, and UNESCO Chair on Karst Education).

The talk was about varieties of caves, karst, and their relationship to the people. With a growing population, people are increasingly causing problems for the karst and its subsurface. She presented the basis for all cave and karst protection and sustainable management activities is knowledge and understanding.

The presentation was followed by a short break with a loop of photos, synthesized and shown by Anja Hajna, from the world's caves and karst areas. The photos were donated by 64 photographer in 18 countries.

After the break, the Discussion Panel was organized with introductory presentations:

• "Safe and Sustainable Use of Karst Resources," by Prof. Dr. Fadi Nader (Lebanon, UIS Secretary General, Earth Sciences & Environment Technologies at IFP Energies nouvelles, and Department of Earth Sciences at Utrecht University).

Beyond groundwater and quarrying for building materials, and tunnels for transportation, carbonate and evaporite rocks that are often karstified and termed as karst host significant amount of resources, that have been essential for societal developments since centuries.

For a safe and sustainable exploitation, we need (1) to better understand the processes associated to karstification, (2) to improve worldwide mapping of the subsurface karst, and (3) to be able to quantify and predict the impacts of societal use of the subsurface on karst.

The talk provided a first estimate of UNESCO protected areas (Biosphere Reserves, Ramsar Sites, Global Geoparks and World Heritage Properties) related to karst landforms or caves. In those protected areas there is a need to develop inventories of all karst features, caves and their contents.

• "Conserving Caves and Karst in Biosphere Reserves: Man and Biosphere Program (MaB - Man and the Biosphere)," presented virtually by Clayton Lino (Brazil, President of the Atlantic Forest Biosphere Reserve and one of the coordinators of the CaveMAB program).

The talk focused on the importance of synergy between the studies and actions of speleological entities and the MAB program, highlighting the actions of the CAVEMAB Network, created in 2018 and integrated by Brazil that have caves and karst in their territories.

• "Karst and UN Agenda 2030," by Dr. Paul A. Griffiths (Canada, Honorary Research Associate, Vancouver Island University, and Member of the Standards Council of Canada Mirror Committee for ISO/TC 319 Karst).

Not unlike karst itself, the UN's Agenda 2030 and its 17 Sustainable Development Goals (SDGs) have been called an "integrated package"—complex and interwoven.

This talk considered a few of the SDGs bearing on karst. Achieving SDGs in all karst regions will require a concerted global effort that cannot rely upon UNESCO protected areas alone.

At the end of the lectures, the speakers answered questions sent by Zoom and the ceremony was closed. The celebration was recorded and is available through the link https://www.youtube.com/watch?v=6-yIDYpPfiQ&t=5803s.

Following the public celebration, UIS organized a business lunch meeting with invited UNESCO officers and ambassadors in the UNESCO restaurant located on the $7^{\rm th}$ floor of the complex. In this informal environment, the UIS took the opportunity to further strengthen relations with UNESCO and delegates from various countries.

BUILDING ON THE CELEBRATION

As noted in the UIS President's Column on *page 4*, the celebration at UNESCO was a new beginning for speleology, and the work toward that better future began the next day. We were kindly welcomed at the offices of the Brazilian Delegation at UNESCO by Mayra Yonashiro Saito, of the Brazilian Ministry of Foreign Affairs. Mayra was very receptive to the purpose of the IYCK and the efforts of the UIS in favor of the caves and the karst. She also promptly arranged a new meeting for us the next day.

We met outside the formal UNESCO environment with Tales Carvalho Resende who works in the UNESCO World Heritage Center on topics related to the protection and conservation of natural heritage. Previously, Tales worked on UNESCO projects focused on groundwater and offered to seek synergies between the UIS and UNESCO for the realization of cave and karst studies in world heritage sites, as well as awareness-raising actions on the importance of caves and karst during activities related to World Water Day, whose central theme for 2022 will be "Groundwater: Making the Invisible Visible."

Among the many activities scheduled to gain the needed attention for the role of global underground water resources, the Summit is scheduled for December 2022 in Paris. For more information, go to https://www.un-igrac.org/agenda/groundwater-summit.

Given the relationship between the theme and karst, we hope that the UIS and the international spele-ological community can participate actively.

POSITIVE BALANCE

In general, the presence of the UIS in UNESCO, besides being historical, is a success. The messages transmitted during the event and at subsequent meetings are continuing, and in addition to UNESCO are expected to reach governments and national and local organizations.

Our thanks go to everyone involved in the organization of the UNESCO IYCK 2021 Paris event, to all participants who supported us on the Internet and especially to the Permanent Delegation of Slovenia to UNESCO, which was our co-organizer.

Coincidentally, the ceremony was 300th event dedicated to the International Year of Caves and the Karst. Many more events are continuing and one thing seems certain, the IYCK is changing the way people around the world see caves and karst. May this new mentality be perpetuated beyond 2021 and that the speleological heritage, in short, obtain the attention, respect, and global support that it richly deserves.

PROTECTION OF CAVE FAUNA

INTERNATIONAL CAVE ANIMAL OF THE YEAR 2022: BATS

The International Cave Animal of the Year campaign brings attention to the threats to the world's unique cave fauna, with special attention each year to a particular group of species. The 2022 International Cave Animal of the Year is the bat. The Covid 19 pandemic caused many new misunderstandings and misinformation about bats They did not cause this terrible disease. With the international focus of our campaign, we will raise global awareness of the truth about bats and their need for protection.

The campaign is part of the International Year of Caves and Karst and an initiative of the International Union of Speleology (UIS). The UIS is comprised of 57 member nations and partners like Bat Conservation International and EUROBATS which support the International Year of Caves and Karst.

There are some 1,400 bat species living in the wild around the world without posing the slightest threat to their human neighbours. Bats have been on Earth for more than 50 million years, they are the second largest order of mammals, and are widely dispersed across six continents. Many have adapted to urban environments, living in backyard gardens, parks and even roosting under bridges.

Bats provide enormous benefits to vital ecosystem services in the form of insect pest consumption, plant pollination, and seed dispersal. Insect-eating bats,

on average, can eat up to half their body weight in insects, while pregnant or nursing mothers will consume up to 100% of their body weight each night. Bat pollination is critical for a wide variety of plants, such as giant cacti and agave, and to a host of commercial plant products including durian fruit, cloves, carob, and balsa wood. Without bats, these plants would not thrive.

Globally, 40% of all bat species are currently listed as either threatened with imminent extinction, near threatened or data deficient by the International Union for the Conservation of Nature (IUCN). Much more needs to be done to ensure the survival of bats around the world. While the killing of bats will not have any effects on the spread of COVID-19, it would adversely affect the conservation status of bat populations.

Bats do not spread COVID-19. It is being transmitted from humans to other humans. There is no evidence that bats directly infected humans with COVID-19 in the first place. Scientific investigations are pointing to a chain of events that may have involved bats but most likely only through an intermediate animal. While the exact chain of transmission that resulted in COVID-19 may never be known, humans live healthier and safer when we conserve wild-life and natural habitats. Bats may hold the key to the next breakthrough vaccine or treatment as they have a unique ability to tolerate viruses.

The first International Cave Animal of the Year in 2021 was the cave beetle. Ten UIS member countries presented national campaigns on it. ICE CAVERS: THE MOVIE

n October 2021, under the Palaeolus scientific project, a caving expedition was organized in the White Mountains of Crete with the help of Proteas caving club (*Thessaloniki, Greece*), targeting Europe's southernmost glaciers, "hidden" in caves. During the expedition, the team (**Christos Pennos, Aurel Perşoiu, Yorgos Sotiriadis, and Stavros Zachariadis**) explored and mapped the underground glacier in Laggonia Cave.

Ice, dust and organic matter were sampled for analyses aiming to decipher the accumulation history of the ice body and the dynamics of climate in Southern Europe. Those results are not yet available but will be published in the coming months in scientific journals, with a summary published in a future issue of the UIS Bulletin

A short film detailing the expedition was filmed and edited by Yorgos Sotiriadis and is available <u>clicking here</u>. Financial support for this project was provided by the Executive Agency for Higher Education, Research, Development and Innovation Funding (UEFISCDI) Romania and the International Union of Speleology (UIS). Additional trips to ice caves in Greece, Romania, and Slovenia are planned for 2022.

THE VENUE AND THE LOGO

ear cavers and speleologists around the world, following the UIS's tradition of publishing news about its upcoming congresses in all issues of the UIS Bulletin, we are here once more to present you the main advances in the organization of the 19th International Congress of Speleology (ICS).

As you know, the event in 2025 will combine the 19th ICS with the 38th Brazilian Congress of Speleology (CBE) in a single event, promoted by the UIS and the Brazilian Speleological Society (SBE), with the responsibility for the organization residing in the SBE and the Brazilian National Center for Research and Conservation of Caves (ICMBio/CECAV).

In the last issue of this Bulletin we mainly presented the process involving the Extraordinary UIS General Assembly (EGA) in which the Delegates voted unanimously for Brazil, giving us the honor and the responsability to host for the second time in history the most important speleological event in the world.

In addition, you could learn about the long road covered by the Brazilian candidacy since the first initiative in 2015 up to the video produced in May 2021 specially for the EGA (see again at https://www.youtube. com/watch?v=gwjhHEKEDUQ.).

We also provided you important information about Belo Horizonte-the city selected to host the event-its main characteristics, forecast, traditional food, as well as the preliminary list of attractions for one day and pre- and post-congress excursions. Over these past six months, the work of organization has continued, whose main advances we are pleased to present to you as follows.

VENUE

After analyzing some of the best options in Belo Horizonte to properly hold the UIS congress, three of them were placed on the table so we were able to carefully compare pros and cons of each one.

General view of the Minascentro Convention Center, which occupies entire city center block in the heart of Belo Horizonte. Completely rebuilt and renovated, it offers the most modern infrastructure and technology for big events, like the UIS Congress.

A second round of local visits, then, led us to decide in favor of the **Minascentro Convention Center**.

Occupying an entire city center block, Minascentro has in front the most visited tourist spot in Belo Horizonte—the *Mercado Central* (Central Market)—and is close to a complete commercial center, with a wide range of restaurants, flats, hotels and tourist attractions.

Located just five minutes from the main bus station, Minascentro is 40 minutes from Tancredo Neves International Airport and 20 minutes from Pampulha Domestic Airport. With a total area of 30,164 m²—13,000 m² available for events—it is divided as follows:

- 3 Floors
- 6 Auditoriums
- 18 Meeting Rooms
- 2 Theaters (the biggest with 1,715 seats)
- Parking (80 spaces)
- Business Center
- VIP Room
- Ticket Offices

Built in 1926 to house the Health Department of Minas Gerais, Minascentro has Neoclassical style architecture and is listed by the Historic Heritage of the Municipality of Belo Horizonte. In 1982 work began on the adaptation and construction of theatres, auditoriums and exhibition areas. At the end of 2019, yet another renovation was completed by the government of Minas Gerais, this time to adapt and modernize the building with a view to its privatization.

Among the interventions carried out, the following stand out: replacement of the entire electrical wiring and piping; improvement of the drainage system; installation of the automatic fire detection system; modernization of the air conditioning system; execution of new coverings and waterproofing to correct infiltration problems; restoration of plasters and paintings; restoration of wooden frames; adequacy of sanitary facilities (accessibility); replacement of lighting by a LED system; fiber optic installation, among other improvements.

The administration is now in private hands and the next step will be the implementation of a series of facilities previously unavailable, such as fiber optic internet, computer network, projectors, fire brigade, and food court as well in order to meet all demands of any event. The date of 20-27 July 2025, of course, is reserved to wellcome the international speleological community. We are sure that the participants of the 19th ICS will find at Minascentro all the facilities to fully enjoy the event.

Speleologists and cave lovers around the world are now focused on the trip to France in July 2022 to attend the 18th ICS. Brazilians too, of course, but meantime we will keep working toward 2025.



1) Opening Session of the UIS President / Approval of Agenda

George VENI thanked all participants for the 2021 UIS Bureau meeting (in person and by video-conferencing on Zoom). The meeting consists of two sessions. The first on Sunday 12th of September, and the second on Tuesday, 14th of September. The attending UIS Bureau members as well as Andy Eavis and Pavel Bosak would be part in the IYCK 2021 event at UNESCO Headquarters in Paris on Monday 13th of September.

George VENI started the 2021 yearly Bureau meeting on September 12th with the following statement that expresses well the prevailing historic context: "Tomorrow is our first opportunity ever to meet an organization of global political leaders and tell them how important it is to protect karst. To demonstrate that caves are important. We need to focus today on tomorrow's meeting."

The proposed Agenda of the meeting was then approved unanimously. Several matters were been shared ahead of the meeting in order to have time-framed, efficient discussions.

2) Approval of Minutes of Regular Bureau Meeting of 2020 (via VC on ZOOM)

Published minutes in Bulletin 62-2 (http://uis-spe-leo.org/wp-content/uploads/2021/02/uisb622.pdf).

Fadi NADER reported that the numbering of actions in the minutes was not correct as some repetitions of the same number occur for different actions (cf. Actions 1 to 5).

After review, George VENI proposed to approve the minutes of the previous annual meeting.

Fadi NADER seconded, and the minutes were approved unanimously.

- 2. Guidelines for UIS Prizes 2021 will be added directly on UIS website menu.



11) IYCK 2021 – After UNESCO event (George VENI / Nadja ZUPAN HAJNA)

A roundtable discussion was made to gather the impressions and feedback of the UIS Bureau members concerning the IYCK 2021 UNESCO Event.

All Bureau members agreed that the event was a historical moment for UIS. In terms of the program itself, a general conclusion was made that the presentations were too long and did not allow time for more discussions and interaction with the attendees.

George VENI said that the fact that the UIS was recognized by UNESCO is very important for the international community of cavers (> 500 people watched on YouTube) and that it is important to follow-up and to show how we can benefit the UNESCO network.

Baerbel VOGEL, who attended by Zoom, said that it was very good and that IUCN's resolutions are important for the UIS' future. She also proposed to prepare karst reports.

Nadja ZUPAN HAJNA reflected on the difficult communication with UNESCO technical staff and technical

problems faced during the event, but it was a unique opportunity for UIS to be at UNESCO.

Bernard CHIROL reported from the 18th ICS organizers that they felt that not enough visibility was give to the 18th ICS and their efforts.

Fadi NADER said that what counts most is that we managed after several years and a lot of efforts to address the world from UNESCO asking for the protection of karst and caves, by this alone we must have made all cavers of the world proud.

UIS Archive – Postojna, Slovenia - Short Report to the UIS Bureau meeting – September 2021, Paris

UIS Archive is located in the 3rd floor of the historical building (Castle), the seat of the IZRK SAZU and the UIS (Titov trg 2, Postojna Slovenia). Place and furniture granted by the IZRK ZRC SAZU.

PRESENT CONTENT OF SHELVES IS AS FOLLOWS (GENERAL ITEMS):

Archive materials from H. Trimmel, J.A. Labegalini, A. Eraso Romero, A.A. Cigna, F. Habe, A. Anavy, P. Forti, C. Ek, P. Bosák, V. Panoš, A. Mihevc, N. Zupan Hajna: correspondence, documents, accounting etc., highly not complete, in

some places only rudimental (missing especially materials from the very beginning, e.g. prof. Géze and others)—accounting plus minus complete from General Secretary: Trimmel, Ek, Bosák and Treasurers: Mihevc and Zupan Hajna.

International Congresses of Speleology, from 6th 1965 Postojna/Ljubljana up to 17th 2017 Sydney: official materials issued by Congress organizers are highly incomplete, incl. prints (Proceedings, abstract books, excursion guides, Circulars, leaflets, posters, etc.) as well as other things (badges, T-shirts, bags, flags, stickers, pins, etc.).



What is completely missing are public relation items (news in newspapers, journals, magazines, CD/DVD or similar media with TV/broadcasting, related activities, etc.)—not only related to the UIS Congresses and karst/cave events, but also to UIS activity itself.

UIS Commissions: quite rudimental, most of Commission/Working Groups or Commission-related prints are not available. Missing documents related to activity of most Commission and WG.

Leaflets concerning speleo/karst-activities, events, education, caves etc.

Relations with UNESCO before 1997: UNESCO prints are nearly complete, missing the early history of relations with the UNESCO (before acceptation as former C category of affiliated institutions).

Principal documents of the UIS: versions of Statutes, Reglements, Recommendations for Congress Organizers are also partly incomplete, only rare documents concerning the UIS foundation are in Trimmel's boxes.

Relations with ICS, ISCA, IUCN, IGU, FEALC, SFEU are also highly incomplete.

UIS Bureau Meeting (regular/annual, not regular): highly incomplete documentation before 1993 and after 2009.

UIS Bulletin: prints of Trimmel and Bosák (Editors-in-Chief) complete + 20 pcs of each 1991, 1994-2005 and related items (addresses for distribution, originals for prints).

Archive contains also all documentation related to book Paleokarst (Academia-Elsevier 1989)—the first book printed by international publishing house where the UIS is mentioned (includes also correspondence, print foils etc.; donated by Bosák).

The archive includes also journals and some monographs and other prints obtained as exchange copies for UIS Bulletin obtained by past Secretary General (Pavel Bosák). It is completed by some duplicates (monographs) from different sources. Both journals and monographs are organized according to size (smaller or larger than A4). Journals are organized according to journal name; monographs according to registration number.

The archive collects also some speleo/karst-related calendars and posters; those will be delivered to the Notrjanski muzej (Postojna) with good collection of such prints, except items related to Congresses and other UIS activities/event.

The archive collects also some pins and stickers (all karst/speleo-related).

The archive is equipped by PC donated by the Institute of Geology, Czech Academy of Science, new one 2021 will be delivered to Archive on autumn 2020 and is already prepared in the box.

There is also cloud deposit (donation of Z. Motyčka) with some content, but very limited.

The archive materials are not scanned and arranged according to archive demands. The evidence is only basic – what is on which shelve, list of boxes and their rough content etc. The materials (documents, prints, etc.) are mostly collected in hard-paper Archive Boxes, some (e.g., correspondence of J.A. Labegalini) is simply bounded without cover.

There is still quite good place in the UIS room in the IZRK ZRC SAZU for future documents, prints and all items related to the UIS activity sensu lato (i.e. Commissions, etc.); nevertheless, in the Institute, there is pressure for space for young scientists...

THE NECESSARY STEPS FOR FUTURE (RECOMMENDATIONS):

- More intensive interest of present and past UIS officers (UIS Bureau Members and Honorary Members, Commission/WG officers, UIS-related event organizers, especially of the UIS Congresses, etc.) to deliver all UIS-related materials (printed, not-printed, public relation, others) to the UIS Archive CONTINUOUSLY, not only after termination in function. If not delivered continuously, materials are lost (thrown out after the respective person dies)!;
- To look for any UIS-related materials, especially from 1950 to 1965 but also younger, in archives of past-UIS officers and/or in their inheritances! to try to fill blind time-sections (hint sunt leones);
- Complete documentation of not printed documents, paper by paper, document by document, thing by thing according or close to archive customs to find personnel to do that and finances;
- Complete scanning and/or photos of not printed documents/things and deposition of electronic versions in the cloud.

IN MEMORIAM

PETER ERNEST SPARGO

South Africa, 1937-2021

eter Ernest Spargo was born on 07 June 1937 and educated and worked in the (then) Transvaal until 1976 when he was appointed Senior Lecturer in the Science Education Unit of the School of Education at the University of Cape Town. By 1980 he had been promoted Director of its Science Education Unit where he stayed until retirement in 1997.

One of his many research interests, which he followed on his arrival in Cape Town, was the history of the many abandoned mines in the Western Cape. This came to the attention of the South African Spelæological Association (Cape Town Section), whose members helped him to explore and survey these subterranean artefacts. Over the years he frequently wrote, and spoke about the mines:







His role in the Gcwihaba Caves Project

first met Peter Spargo when I was introduced to him at a South African Spelaeological Association (SASA) conference held in Prieska during the mid-nineties. The purpose of the conference was for the two sections of SASA, the Cape Section and the Transvaal Section, to decide on a new constitution which would allow other caving organisations in South Africa to join the Association.

To serve as an invigilator for the conference, Stephen Craven from the Cape Section recommended Peter Spargo, who was not a member of either section at the time, to fulfil the role. Stephen's proposal was duly accepted and members from both sections along with Peter met on a farm outside Prieska where the conference was held. The conference was a success and in time the Cave Exploration, Rescue and Adventure Club (CERAC) and the Potchefstroom Potholing Club (PPC) both joined SASA.

In later years at a time that SASA needed to appoint a new National President, Peter's name was put forward and in 1997 he was duly appointed as the National President, a position in which he served until he stepped down in 2017 due to ill health. Over the years I regularly communicated with Peter and enjoyed the occasions we could get-together on his visits to Johannesburg and discuss SASA matters and life in general.

During the course of Peter's presidency, the Gcwihaba Caves Project came into existence in 2001 when the then Vice President of Botswana, Ian Khama, first invited CERAC and then later the PPC, to participate in the project. The project, which is probably one of the most unique and exciting in the world, is to discover and

explore new caves in the remote north of Botswana and to establish a new National Park in which the caves play a major role. The Park has been cited for World Heritage status and is intended to add to Botswana's diverse

tourist attractions and to bring revenue into the area to benefit the local populace.

Peter, excited by the prospect of a member group of SASA being involved in an international project, immediately set about establishing communications with myself as the Caving Expedition Leader on the Gcwihaba Caves Project, and from thereon requested that I keep him fully up-to-date on all developments and to send him copies of the reports and presentations given to Ian Khama, who later became the President of Botswana.

Peter's response to my emails and correspondence was inspirational, he never failed to take great interest in our activities and to follow every development with enthusiasm and encouragement. A selection of his comments below certainly reflects on his passion for the project:

- Anyway, may I say how delighted I am to read that the recent Koanaka Expedition was obviously a major success, reflecting extremely well on South African cavers and their skills. May the next one in the series be equally, or even more, successful.

Emeritus Associate Professor Peter E. Spargo: 1937–2021



e are deeply saddened by the death of Emeritus Associate Professor Peter Spargo on 2 August 2021 in Rondebosch. Peter joined the Faculty of Educa-

Peter joined the Faculty of Education at the University of Cape Town (UCT) in 1976 as a senior lecturer in Science Education and became the director of the Science Education Unit in 1980. He retired from the School of Education in December 1997.

Peter completed a BSc(Eng)(Metallurgy) at the University of the Witwatersrand (Wits) and obtained a Postgraduate Certificate of Education from the University of Cambridge. He worked as a Physical Science high-school teacher before joining the Johannesburg College of Education and later the Transvaal Education Department in various lecturing and curriculum planning capacities for more than 10 years. His arrival at

UCT coincided with the general establishment of science education as an academic discipline, and he, together with his contemporaries at Wits, put science education on the map in South Africa.



Peter had a great number of interests and passions, encompassing chiefly the history of science in its broadest sense, science teacher education, and the natural environment. He developed a strong interest in Sir Isaac Newton's alchemy experiments, which he carefully catalogued and analyzed in light of modern chemistry. Peter's work here led to another, rather unique, hypothesis: Could Newton's

clearly documented "derangement of the intellect" possibly be attributed to exposure to heavy metals—known to produce nervous symptoms—as a result of his chemical experiments?

In a fascinating account, Peter was able to show that Newton's hair indeed contained traces of several heavy metals in much higher concentrations than in modern hair, providing circumstantial evidence for the hypothesis as to the cause of "Newton's so-called 'nervous breakdown' of 1692/93". Perhaps not surprisingly given his interests, Peter was the General Secretary of the Royal Society of South Africa from 1986 to 1990, being elected a Fellow of the Royal Society of South Africa himself in 1987.

Peter enjoyed a 'helicopter perspective' of issues and was passionate about the role of science and science education in South Africa's development and prosperity. He established the SA Association of Teachers of Physical Science (SAATPS) and the Federation of Science and Mathematics Teachers' Associations of South Africa, and was the organizations' first chairman and first president, respectively. Being very well connected, Peter was able to bring together participants from industry, provincial education departments, the Chamber of Mines, statutory research organizations, universities, and professional science organizations in a three-day workshop to consider and to recommend how school science might be strengthened. The resulting document —A science education policy for South Africa—was very influential in the 1980s.

As a teacher, Peter was engaging, provocative and interesting. His lectures were an exciting combination of science, history of science, and pedagogy, always stressing the relevance of science in everyday life and its possible role in South Africa's development. He trained hundreds of science teachers, and their passion, skill and insights are very much due to Peter's charismatic

and absorbing approach to pre-service science teacher education. He was regarded as somewhat eccentric and known for speaking his mind and for not suffering fools gladly; many a student (and staff member!) was sent packing with a withering comment. However, despite the appearance of a somewhat stern demeanour, Peter was mischievous and funny, and was a social being right to the very end. His dinner parties for postgraduate students were legendary, invariably ending with port and serious debate of one or another issue ("So, do you think we'll ever find a cure for AIDS?").

In his spare time, Peter loved to walk in Kirstenbosch and up Skeleton Gorge / Nursery Ravine, often weeding parts of the forest floor to remove young alien vegetation but—much to the bewilderment of his family—leaving the weeds in his own garden untouched! His curiosity of the natural and man-made world, and his beautiful craft of writing, made it possible for him to publish all manner of interesting pieces for wide-ranging lay audiences, the topics ranging from mining coal in the Kruger Park to changes in the water temperature of Colonel Bird's bath in the Kirstenbosch Botanical Garden and his family's adventures in Mordecai—a 1948 Chevrolet Fleetmaster.

Peter's connection to and interest in mining also yielded an historical account of early mining activity at the Cape. He additionally provided a careful description of the only true mining venture within the city of Cape Town – the Vredehoek tin mine.

Peter is survived by his wife, Celia; four daughters (Cathy, Margot, Marion, and Trish), and his eight grandchildren.

The UIS General Assembly at the 17th International Congress of Speleology (*Sydney, Australia, 2017*), approved the amended fee categories of member countries, which are based on the number of speleologists in the national organization or organizations that represent the country to the UIS.

The new annual contributions are as follows, starting after the 17th ICS, Sydney, Australia:

Category A: 2,000 speleologists or more	480 Euros
Category B: at least 1,000 but fewer than 2,000	360 Euros
Category C: at least 100 but fewer than 1,000	240 Euros
Category D: less than 100	60 Euros

If the fees are not paid for more than five years, the Member Country will lose its membership in the UIS.

The UIS Bureau may reduce or waive the fee of a Member Country if the Member Country makes a written request describing the reasons why it is having difficulties making its payments and how long those difficulties are expected to continue. All fee payments and related communications are conducted between the UIS Treasurer and the Member Countries.
